We love fresh veggies, fruits, pasture fed meats and raw milk at C'est Naturelle Farms, we love milking and caring for our cows, raising delicious crops and we love that we are able to offer our members access to these crops and products.

We also believe in obeying the laws of the land. In order to accommodate both our customers desire to have raw milk and other raw produce available for them and the current Oregon State Laws concerning the sale of raw milk we are offering our customers part ownership in our dairy herd and a customizable portion of the harvest in the garden.

#### Ownership agreement

I/We \_\_\_\_\_ agree to purchase from today's date of \_\_\_\_\_ for the duration of 12 months part ownership in the dairy herd and the right to purchase a portion of the harvest of the garden for the price of \$10. As an owner of the cows and a participant in the crop harvests I agree to compensate the farmer for pasturing, feeding, milking, and any required health care for my animal at a per gallon/lb/half gallon rates and to pay established prices for any field crops or bulk food items.

I agree and understand that "raw" milk and the products which come to me direct from the garden are raw agricultural products and I accept all of the health benefits and concerns associated with it, and I do not hold C'est Naturelle Farms responsible for any food borne illnesses associated with raw milk or raw food consumption.

I have been informed and understand that I (the buyer \_\_\_\_\_) am buying raw cow milk and raw agricultural products. I will not hold C'est Naturelle Farms, Vernie or William DeMille, any farm laborers, other herd owners, or associated land owners responsible or liable for any injury, in any way, after purchasing this membership and receiving the products of my cows (namely raw cows milk, raw cows cream, and raw milk butter, and any or all raw milk products as decided by the herd owners) or my garden harvest (consisting of any food products raised, packaged, or produced by C'est Naturelle Farms).

I understand that I will not pursue any legal actions, suits, claims for relief, demands, damages, and any other obligations, known and unknown, suspected and unsuspected, in law or equity, direct or indirect, and whether now or in the future, for any injury or death arising from use of this product what-so-ever.

I agree that at the end of my 12 month ownership period C'est Naturelle Farms has the right to re-purchase my portion of the herd and harvest for the agreed upon price of \$10. I agree that I may not sell my portion of the herd to anyone else without the knowledge and agreement of C'est Naturelle Farms.

I understand and agree that I will be charged a \$20 bottle deposit fee should I choose to purchase milk from C'est Naturelle Farms. If I fail to return my milk bottles within the determined time frame (usually 2 weeks) I understand that I will forfeit \$2.00/bottle for each unreturned bottle. I also understand that this bottle deposit is 100% refundable after the duration of my farm membership, if within 2 weeks of each bottle of milk I receive all bottles, lids, and rings are returned to C'est Naturelle Farms.

I understand as a farm member that it is my responsibility to ensure that any product I purchase is cared for properly to guarantee its freshness and quality. Therefore I agree to do the following:

1. Provide a cooler or share refrigerator and cooler space at my chosen drop-site depending on availability.
2. Notify C'est Naturelle Farms within 48 hrs. of receipt of product if there are any problems with my delivery or items. No refunds will be offered after 48 hrs.
3. Notify C'est Naturelle Farms in a timely fashion if I need to change my order for any reason including but not limited to: vacation, illness, work, etc.
4. Contact my drop-site host prior to my first pick-up day to determine the best time, method, and protocol for my drop-site. Remember: our drop hosts are all volunteer and we want to make it as easy for them as possible!
